

# ASKS TO BE ACCREDITED TO 38° SANREMO RALLY STORICO 2023

ATTACH to this letter of assignment on letterhead, signed by the Responsible Director or his or her deputy, evidencing the collaboration.



For those accredited as photographer and video operator, it will be mandatory to use the tabard that will be given at the time of accreditation. PLEASE NOTE: photographers and video operators must show personal accident and liability insurance certificate.

## **RULES FOR PRESS ACCREDITATION**

Journalists, photojournalists, cinematographers, including Free Lance, and radio operators must present in original copy the application for accreditation formulated by a newspaper registered with the court of the relevant territorial jurisdiction. Acceptance of the application for accreditation is subject to the endorsement of the press office of the event organizer. Each application will be verified so that the actual conditions for the issuance of accreditation exist and, if applicable, also submitted to the supervision of the competent National Sports Federation or other designated entity. Each media or agency may accredit a maximum number of no. 2 journalists and/or collaborators and no. 2 photographers. Any other request may not be granted except in cases deemed suitable by the press office and approved by the competent National Sports Federation.

Just sending the accreditation request does not in any case represent its acceptance by the press office.

#### **FREE LANCE**

Free-lancers must document the publication of photographs and/or video images on newspapers/magazines and television during the previous year. They are required to certify their registration with the CCIAA, the attribution of VAT number (with certifications not older than six months) and any valid registration with the National Order of Journalists or other professional associations, in addition to proof of the declared collaboration.

# LIVE VIDEO AND TV BROADCASTS AND LIVE SOCIAL BROADCASTS

The granting of the pass **DOES NOT AUTHORIZE** the holder to broadcast images of the event via live video/tv or direct social media, excluding any initiatives agreed, in the manner and terms, with the organization of the event and subject to the approval of the National Sports Federation. Any abuse will result in the withdrawal of the accreditation credential and will be reported to the judicial authorities.

## **LIABILITY STATEMENT**

The applicant for accreditation as specified above declares that he/she is aware of the dangers that may exist in the context of motorsports events and in assisting the sport event along the route. He/she also declares that he/she has the experience and professional preparation to assist, in safety, the event and that he/she is committed to every precaution necessary to avoid physical and material damage to himself/herself and others; to respect the safety orders given by the Marshals and the Police; to assume any and all responsibility for any damage he/she may suffer, due to his/her own imprudence or inexperience. To release from any and all civil and criminal liability the Organizing Committee, the Race Director and any other person, Institution or Association connected with the Event for what is extended above. The undersigned also agrees to comply with any provisions regarding the use and validity of the pass that may be communicated by the Press Office. Press accreditation is issued only to those over the age of 18. The pass is delivered by the



Press Room EXCLUSIVELY to the holder who has requested it (no exceptions are allowed), it is strictly personal and its transfer to third parties is strictly prohibited. Any misuse will result in immediate withdrawal and will be reported to the judicial authorities and to the competent National Sports Federation or entity in charge.

## PRIVACY POLICY INFORMATION

Pursuant to Article 13 of Legislative Decree No. 196/2003 (hereinafter "Privacy Code") and Article 13 of EU Regulation No. 2016/679 (hereinafter "GDPR 2016/679"), laying down provisions for the protection of persons and other subjects with regard to the processing of personal data, we wish to inform you that the personal data you provide will be processed in accordance with the abovementioned legislation and the obligations of confidentiality to which the organizing body of the event is bound. The personal data you provide are necessary for the fulfillments required by law, and for purposes related to the conduct of the event. We also inform you that the data collected will never be spread and will not be communicated without your explicit consent, except for necessary communications that may involve the transfer of data to public bodies, consultants or other parties for the fulfillment of legal obligations.
